About ICADLA

- The goal is to generate synergies for creating a digital portal of Africana scholarship and cultural heritage resources
- ICADLA-1 was held in Ethiopia on 1-3 July 2009, with a follow-up ICADLA-2 in South Africa on 14-18 November 2011.
- Formats: ICADLA-1 comprised a Strategic Roundtable with Intergovernmental Organizations on putting knowledge on African development agenda & presentations on strategies for the African Digital Future; ICADLA-2 was a 3-day training workshop on digitization matters & a 2-day strategic planning conference.

The Pointers

ICADLA-1

- An umbrella body to provide oversight for creation of the African digital library & archives
- Development of strategic framework and road map
- An integrated information platform for Africa which will permit sharing of knowledge across partnering countries is needed

ICADLA-2

- Promising partnerships : World Digital Library, ESARBICA, New York Academy of Medicine, Internet Archive, British Library, Finland
- Promising capacity development initiatives: African Digital Library Support Network and Open Access Repositories the Capacity Strengthening Programme for Africa (OA-IRCSP)
- Cost saving open source software: Greenstone & DSpace
- Models: World Digital Library, the Internet Archive, Norwegian National Digital Library and Europeana

What has been learnt from ICADLA?

Challenges

- Absence of national & institutional digitization strategies
- Thinly spread skills
- Slow uptake of metadata & technical standards
- Insufficient mastery of intellectual property & copyright issues
- Inability of institutions to exchange records
- Numerous collections not yet accessible online
- Inadequate project funding, marketing & equipment.


Lessons

- Donor-driven approaches may not always necessarily meet institutional needs
- Partnerships with organizations such as the World Digital Library, Internet Archive, British Library & Finland may assist in capacity building
- Initiatives such as the African Digital Library Support Network & Open Access Repositories the Capacity Strengthening Programme for Africa (OA-IRCSP) have supported capacity development

Outcomes

- ICADLA-1 raised awareness among leaders & programme managers

- The ICADLA-2 workshop created a trained pool of 35 experts from Archives, Libraries & other memory institutions
- Institutionalization of ICADLA through a Convening Committee, Standing Committee, & International Advisory Committee
- Articulation of ICADLA Agenda: Digitization training & development; Audit of Africa digitization projects; Deepening of projects; Development of discovery tools; position paper for tabling at AU Summit in June 2012; Conferences & Partnerships to sustain the initiative
- Confirmation of the venue for ICADLA-3, in Morocco, to extend opportunities to North, West & Francophone Africa
- Identification of the building blocks for the African Digital Library & Archives, including resources & partnerships
- ICADLA welcomes partnering with Casa África in arranging and running a mid-term training workshop pending the holding of ICADLA-3 in 2013 & is open to exploring any other mutually beneficial collaborative initiatives that may arise from ongoing dialogue.


